Act No. 58 (R80, S3)), which went into effect on June 4, 2015, replaced the crimes of “criminal domestic violence” with the crimes of “domestic violence.” Only conduct occurring prior to June 4, 2015 is prosecuted as “criminal domestic violence” crimes, thus the number of such crimes prosecuted drops each year.
